TERMS AND CONDITIONS FOR REGISTRATION AND PARTICIPATION

These terms and conditions apply for the participation to the 4th International Symposium on the System of Radiological Protection (ICRP) and the 2nd European Radiological Protection Research Week (ERPW) hereafter named “Conference” to be carried out by the Institut de Radioprotection et de Sûreté Nucléaire (IRSN).

Registration to the Conference is subject to validation of the present terms and conditions for registration and participation.

1. Registration Prices

a. Full symposium (from Tuesday 10th to Thursday 12th October)

- Meeting attendance
- Coffee breaks
- Lunches
- Welcome reception on Tuesday
- Gala dinner on Wednesday
- Delegate brief case
- Electronic version of the Conference proceedings

b. One day attendance

- Meeting attendance
- Coffee breaks

- Welcome reception if the chosen day is Tuesday
- Delegate brief case
- Electronic version of the Conference proceedings
- Optional: Gala dinner

2. Registration Modalities

Subject to the conditions hereafter defined, registration to the Conference above defined may be made through:

- Either online registration on ICRP-ERPW2017 website, www.icrp-erpw2017.com from March 17th, 2017 until October 8th, 2017;

- Or on-site registration on the Conference site only from October 9th, 2017 and October 12th, 2017.

One registration is made for one participant. In the contrary no registration request shall be taken into account.

In any case, confirmation of registration and payment will be sent via e-mail by the Secretariat of the Conference to the participant email address given in the registration request.

In any case, no registration will be processed or confirmed until payment of the full amount has been duly received on dedicated bank account, and cumulatively if so apply, until presentation of written justification for reduced rate.

No modification of the online registration is possible once the registration form is validated.

3. Applicable Rates

Prices are settled in Euros (€) and all taxes included.

Accompanying Person Registration

Accompanying Person may only take part to the Conference's dinner subject to the applicable rate above and provided that the participant with whom the Accompanying Person is taking part to the dinner is regularly registered and has paid all necessary subscription fees. In addition such Accompanying guest must be clearly identified on Participant subscription form.

For avoidance of doubt, only one subscription form is required for both the Participant and the Accompanying Person if applicable.

4. Terms of Payment

Payments are made only by credit/debit card (Visa or Master Card).

Notwithstanding the foregoing, payment may be carried out by wire transfer, subject to prior written approval of the Secretariat of the Conference.

Payments made at the Conference site may only be made by credit/debit card (Visa or Master Card).

Payment must be carried out without deduction of any kind and notably without any bank fees of any kind including without limitation any exchange fees. Any dispute relating to an invoice shall be noticed to the Secretariat of the Conference at the time of the Conference and not later than thirty (30) days after the last day of the Conference.

5. Cancellation

Cancellation of registration to the Conference remains possible subject to the following conditions:

- Cancellation requests must be done by writing an email to the Secretariat of the Conference; Bank information details must be joined to the email according to conditions of article 6 hereafter;

Financial conditions apply as follows:

- If the cancellation email is received between March 17th, 2017 and May 31st, 2017 at the latest, one hundred per cent (100%) of the registration fees will be reimbursed;
- If the cancellation email is received between June 1st 2017 until August 31st, 2017 at the latest, fifty per cent (50%) of the registration fees will be retained;
- Cancellation received after August 31st, 2017 won't give rise to refund possibility and registration fees will definitely remain to IRSN.

6. Refund modalities

In respect to the above mentioned provisions, refunds will be made by IRSN on the bank references transmitted for cancellation request, bank references which must remain the same bank references transmitted for the payment.

7. Insurance and liability

IRSN may cancel the Conference for any reason. In such case, IRSN shall reimburse the registration fees already paid.

In case IRSN would postpone the Conference, in such case may either refund the registration fees upon request, according to article 6 above or maintain the registration fees for the new date.

Notwithstanding the foregoing, IRSN shall not be held liable for any case of force majeure according to its definition given in Article 1218 of the French Civil Code.

IRSN has subscribed insurance policy, for which civil liability guarantees the Conference.

Such liability does not apply to:

- Damages caused by third party(ies) to participants or caused by participants to third party(ies).
- And damages caused to goods under the participant.

IRSN shall not bear any liability in case of accident which may involve directly or indirectly participants, neither during or after the Conference, nor any event organized beside the Conference.

8. Rights on participation

During the Conference, the participants may be filmed or photographed either individually or in group. By accepting the present terms and conditions, he/she accepts to be filmed or photographed.

In consideration of the registration to the Conference, he/she accepts to abide by all applicable rules on the site on which the Conference will be held, including IRSN and its providers organizing the Conference's orders or instructions.

Non respect of these regulations shall lead to participant's exclusion from the Conference, at the sole initiative of the organizers without any notice and without right to registration fee refund which will remain IRSN's benefit.

9. Miscellaneous

IRSN reserves the right to change, modify, make additions or suppressions to the present terms and conditions for registration and participation at any time.

In case of interpretation between the English version and the French version of the present terms and conditions, the French version shall prevail.

10. Applicable Law

The present terms and conditions are subject to French Law and any dispute not solved amicably shall be settled before the competent court.
